## Terms and Conditions

**AGREEMENT:** A firm and binding agreement exists between Dakov Photography (Studio) and Client only after a retainer has been paid. The retainer is non-refundable and must be paid at the time of booking, with the remaining balance due and payable at least two months prior to the event date. This initial retainer is made to secure the exact date for the Studio services. If the total of the session is less than \$750 USD, the full total of the session must be paid up-front. It is the Client's guarantee that the Studio will not book someone else in Client's time slot. If the client cancels the order or wedding less than 2 months prior to the studio supplying the service, the Client will be liable for the whole invoice value less any retainer already paid. If the Client cancels their order more than 2 months prior to the Studio supplying the service, they shall forfeit the retainer.

**DISPLAY RIGHTS:** All digital photography shall remain property of the Studio. It is understood that the Studio has the exclusive right to reproduce and use all images for public display, advertising, and/or exhibition, unless Client gives non-consent at time of booking. All images produced and/or edited by the Studio is protected by Copyright. It is understood and agreed that the Client cannot copy or have copies made of the raw images. The client is granted a license to use the images only for private home and family use. Any other permission for the client to use the images must be granted in writing by the Studio.

**PRODUCTION & EDITORIAL CONTROL:** The studio is the exclusive official photographer retained by Client to cover event. Studio is granted full production and editorial control by Client regarding all aspects of the production and post-production services for this event. If something occurred at the wedding that Client does not want to appear on, the Client must instruct studio before editing begins.

**WORKING CONDITIONS:** Client must provide a safe working environment and is responsible for any damage to equipment done by guests.

**EDITING & USE:** Client agrees that the studio is editing in our own artistic style, a wedding seen from our own eyes. The studio reserves the exclusive right to edit all photos. Additional copies will be made from the original files and by the studio. Client is granted only a license to use production for private non-profit uses, unless other permission is granted in writing by the studio.

**DELIVERY:** Images will be available for viewing online in 6-8 weeks after the event. A high-resolution DVD disk will be shipped to your address on file. Album and print orders vary depending on design time and vendor binding and printing times. The completion period is only an approximate length of time and any longer periods necessary for completion will not void this contract. The Studio cannot accept responsibility for material lost or damaged in transit.

**MEDIA RELEASE NOTICE:** Client agrees to provide general notice to all guests and service providers that the session will be photographed. With this notice, and by virtue of their attendance, all guests and service providers acknowledge and give permission for the use of their images by the Studio.

**FOOD:** The client agrees to provide a meal at the reception for each of the film crew (usually 1 or 2 people) if the coverage is over 5 hours. The studio is not responsible for any activities missed during this break/meal time.

**COVERAGE & TRAVEL:** The studio will provide any book any necessary travel arrangements. If your wedding or event is outside the state of Florida additional travel fees may be imposed such as hotel, transportation and airline tickets, luggage fees, food, countries duties and taxes. If the Client wishes to make arrangements ahead of time for the Studio, these travel fees will be waived in partial or full. Additional coverage beyond your initial schedule costs \$250/ per hour.

**WEATHER / ACT OF GOD:** The Studio will make necessary changes due to weather disturbances. We take every care to perform to our client’s needs but things there are things that are beyond our control such as a fire, hurricane, etc in which case may prevent us from shooting. In the event of cancellation by the Client, the deposit is non-refundable. Rescheduling is subject to a 25% surcharge and at the sole discretion of the Studio.

**LIABILITY AND GUARANTEES:** The Studio’s liability is limited to refund of money paid. The Studio takes the utmost care in producing Client’s services. In the unlikely event that a problem arises and Studio is unable to provide any photographs, all fees paid will be refunded. The Studio is not responsible for loss of image quality due to restrictions at event locations. The Studio does not guarantee any particular shot, effect, or special request. In the very unlikely event that an emergency arises (extreme sickness for example) and is unable to perform the whole service, the Client will be notified immediately and all money paid (including retainer) will be refunded to the Client.

**ATTORNEY FEES AND COSTS:** Client will be liable for all costs of collection under this contract including all legal fees.
